11 min. Speech for Officeholders

From Psalms "Without love, the nations' counsel comes to nothing. The plans of the people are futile."

For this reason I come here and invoke the name of love.

Hello. My name is Elle Morgan and I live with my husband of 38 years in a house we bought in the borough of State College. Twelve years ago we found the most run down house in the best neighborhood and fixed it up. We have wonderful neighbors and enjoy peace and tranquility, except during Game Days.

We truly love living in Happy Valley. It's like living in a bubble isn't it? Where life is good and the people are happy. Right now, that bubble is tinted blue. And this shading of blue is keeping us from having a clear vision of what is actually happening around us.

I am not bashing the Democrats. I happen to be one.

I am not here to argue or debate politics, and although I will be bringing up a controversial and divisive topic, I am not here to defend or deny so-called conspiracy theories.

I am here as a wife, mother, teacher and citizen to let you know that evidence is mounting that citizens must wake up and take responsibility for our own health and the health of our families. Because our medical system is failing us. We are getting sick and dying, and in fact the gov't is the most ominous threat of all.

Today, I would like to focus my talk with you on the following: The mRNA gene therapy—not vaccination, the mandates that are still present in our county, and the rise in vaccine injury and death especially among the young.

I teach public speaking at Penn State University. At the beginning of every semester, I get a roster with students' names. I always look them over, and wonder who they might be, what spark they have, what contributions they will make to my class and then the world?

Here are some names:

Daniela Lee '22 Lisa Nguda 24 Tara Atlur '24 Shawn West '24 Yiannis Stathopaulos '24 5 names, along with their graduation dates. They are not from Penn State, they were from Cornell University. And they will not be graduating with their class. They are all dead. Cause Unknown.

They died in the years of the vaccine rollout–2021 to 2022. Is there a correlation? Doing my research for this talk for you, I went through the Cornell Memorials for the years of 2018 to 2022. You can do the same. Every name on the list before 2021 was a person in their older years, mostly 70s 80s 90s, accidents, and long term illnesses. Boom, we hit 2021 and 2022 and we get 5 students 18 and early 20s dead—Cause Unknown.

I am here today to tell you that you must help to stop this. This IS YOUR bailiwick. We are all responsible to alert the citizenry to this clear and present danger.

Here is what I want you to do:

I want you to do your research, like I did, about the mounting evidence of which I speak. What is causing the exponential increase in sudden deaths among individuals in the prime of their lives? Why are we losing our workforce? Edward Dowd wanted to know the answer.

Dowd is a statistician who worked for Blackrock, a company with a bigger economy than every country on earth except for the US and China. His job was to pick stocks, analyze statistics and identify trends.

He was very good at his job. By the time he left Black Rock the Growth Fund he managed went from \$2 billion to \$14 billion.

Dowd convened a group of insurance industry executives to explore a trend—a **40% increase** in deaths the US in those of employment age during 2021 and 2022

Again, you may say, this is not my bailiwick. And I say it is. It begins with honest reflection. You must first ask yourself...was there any money received in the county to promote these shots, or the fallible PCR tests, or the masks...all of the "safety measures" that did not keep us safe but did train us to comply.

Next I would like you to ask yourself, have you ever turned a blind eye or a deaf ear to those who have a broader perspective of this issue? Discounting them, doubting them and dismissing them? Have you ever scorned those not wearing masks, or put yourself in a category where YOU had the information on the shot, straight from the CDC and everything else was disinformation?

Those are the soul searching questions which are most important.

Now, I would like to tell you about the concrete action I would like you to take immediately on my behalf and on the behalf of the citizens of our community.

- I would like you to submit the resolution that I have for you today to the state legislature and governor which calls for the immediate ban of mRNA injections. And, supports that the state of PA have its own jurisdiction when it comes to health and welfare with no interference by the federal gov't and it's agencies: FDA, CDC, NIH. Or from international org. WHO or WEF. Similar actions have been taken by the states of Florida, Wyoming, North Dakota and Idaho.
- 2. I would like you to print a brochure and make it available to citizens through your office on the countervailing information about the hazards of the shot, providing the credible evidence which has mounted throughout the world, which has been suppressed. And make your brochure known through local media: Centre Daily Times, Centre County Gazette, Town and Gown and State College Magazine.
- 3. I want you to send notices to all companies in the county who have vaccination mandates for employees letting them know of the mounting evidence of injuries and that by having mandates, and knowing the dangers of the shot, they are complicit in the harm that is being done to those injured.

We all must take a lesson from Ed Dowd. We have to look at the "statistics" which happen to represent young smiling faces, such as on the cover of Dowd's book. We have to see the "trend "in Sudden Adult Death Syndrome and we have to "analyze" – ask questions.

One day the people will become angry. Very angry and they will be coming to officeholders demanding action and justice. It would be best for the county commissioners to get ahead of this curve.
