“Contaminated” products

1. Blocking South Carolina use of Covid-19 injections as “contaminated” products is good move.
2. Understand: Products not accidentally contaminated.
3. Products designed, manufactured to be intentionally toxic: **weapons**.
4. No commercial market; no regulation; no consumer safety. Pretense.
5. Independent researchers don’t have access to better data, more time or more \$ than FDA. FDA knew all of this from the start.
6. FDA officials knowingly play supporting roles in gov’t mass poisoning program, as **pretend-regulator**.
7. **FDA reviews, authorizations, approvals have no legal substance.**
8. It’s not Pfizer capture of FDA. It’s **DoD capture of Pfizer and FDA** to jointly conduct covert, biochemical war: **armed invasion of states thru delivery doors of pharmacies and “vaccination” programs.**

US Federal Legal History – 1944-present

- 1913 Federal Reserve Act; 1944 Public Health Service Act; 1969 Chemical and Biological Warfare Program...
- Since 1983, federal lawmakers and presidents systematically decriminalized fraud, terrorism, torture, homicide and theft, when done by government officials and their delegees under “public health emergency” conditions.
- Treaties, statutes, regulations, executive orders, contracts, guidance documents, court rulings.
- **Chemical and Biological Warfare program camouflaged as PHE-EUA-MCM pandemic response.**
- Reports available – 2 p. outline, 14-p overview for Sen. Ron Johnson (Dec. 2022), 33-p timeline
- Since April 2022, nothing inconsistent found. Only more detail confirming internal consistency of laws, programs they authorize, blanket immunity for perps from criminal, civil prosecution.

Project Bioshield Act and PREP Act.

- Two statutes: Project Bioshield Act/EUA (2004) and PREP/PHE Act (2005). Transfer unilateral power to HHS Secretary upon declaration of PHE by HHS Secretary.
- **No Congressional oversight, no judicial review.**
Comprehensive preemption of state/tribal authority.
Blanket immunity for federal officials giving PHE orders and delegates local (pharmacists, nurses)
- Three EOs re: quarantinable diseases -- symptomatic colds/SARS (Bush, 2003); influenza (Bush, 2005); asymptomatic colds/SARS (Obama, 2014)

US State legal history

- 2001 - Model State Emergency Health Powers Act (MSEHPA) –
- Architects: Lawrence Gostin, James Hodge. Turning Point program.
- Pushed through most state legislatures.
- 2002 - South Carolina passed it as “South Carolina Homeland Security Act” (Act 339); **“Emergency Health Powers Act”** (Section 24.)
- Codified at **SC 44-4-110**. Authorizes collection of data and records, control of property, management of persons, vaccinations/treatments.
- Policy Surveillance Program – Temple University **Public Health Law** Research – lawatlas.org/topics.
- Other related laws on SC books. Many introduced 2021-2022
- Repealable.

Benefits of covert mass poisoning programs.

- Demographics, debt, broken budgets.
- Balance budgets without tax increases or supply-side program cuts.
- Demand-side program cuts: shorten lifespans, esp. elderly, sick/disabled, poor, babies, children; impair fertility, decrease births.
- Health care, disability (Medicare, Medicaid, workman's comp)
- Pensions, Social Security
- Education, public schools
- Housing, food programs for low-income

What can Congress do?

- **Congress** – Repeal Bioshield, PREP and the rest of the “public health emergency” structure and withdraw from UN, WHO.
- Likely consequence - BIS and Federal Reserve will cut off money supply, seize assets, crash economy, continue the killing through hunger, homelessness, despair, addiction.
- International banking control mechanism demonstrated 2012-2013: Cyprus, Greece, Vatican. Previously demonstrated 1997 - Asian financial crisis.

What can state governments do? Legislation

- **States** are under same central bank control and budget/debt pressure
- Financial-public health occupation.
- **Repeal SC Emergency Health Powers Act** and related laws.
- Pass legislation block/nullify WHO-UN treaties (IHR, 2005) and federal PREP/EUA laws.
- Consequence - Federal Reserve/Treasury cut off federal \$\$
- US gov. send in military to place state under armed occupation.

Consumer safety

- Presume all product shipped into SC is “contaminated.”
- **Stop and de-fund all “vaccination” programs** statewide.
Grounds: Protecting public from contaminated products.
- Describe it as precautionary, to assess.
- Seize and test all unused “vaccines” (pharmacies, hospitals, clinics)
- **Intercept and test** all new deliveries before they reach points of dispensing (PODs).
- **Destroy** materiel after testing.
- When “vaccine passports” are introduced, issue credentials to all SC residents, without injecting or treating anyone with anything.

Corporate Charters: SC Secretary of State - ATI

- Advanced Technologies International (ATI) DoD military contractor, manages MCDC (Medical CBRN Defense Consortium). ANSER subsidiary. Summerville.
- CEO: Christopher Van Metre. 501(c)3 since 1998; EIN 57-1067151
- 2016 Contract - \$10 billion through 2036. W15QKN 16-9-1002 P00085
- Production/distribution of unregulated, “contaminated” medicines are not legitimate business purposes. [Neither are WMD terrorism, mass murder]
- Revoke corporate charters. Involuntary dissolution, forfeiture.
- **SC 33-31-1430. Grounds for judicial dissolution: fraud obtaining charter; exceed or abuse authority conferred; fraud in business conduct.**
- SC exposure to criminal prosecution by other states: 18 USC 2339 - Harboring or concealing terrorists; 18 USC 2339A - Providing material support to terrorists.

The Global Public-Private Partnership (G3P)

Policy Makers

This is the part of the G3P where policy originates

BIS
Bank for International Settlements (BIS)
 The BIS ultimately controls the money supply & thus global markets, trade and national economies.

Central Banks
Central Banks (Coordinated by the BIS)
 The Central Banks are "going direct" and directly funding government spending. Monetary policy has effectively become fiscal policy.



Think Tanks & Global Representative Groups
 The think tanks & globalist representative groups, such as the WEF, form the policy agendas. Working in partnership with the BIS and the central banks, they set the G3P objectives. These can then be pursued through partnership agreements with policy distributors and enforcers, such as the World Bank and national governments.

Policy Distributers



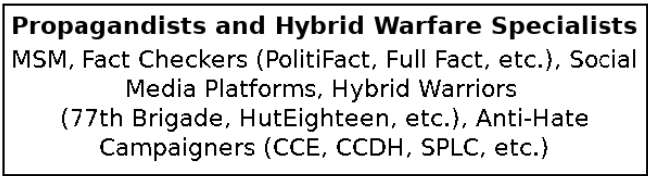
These organisations and bodies take policy directives from the policy makers and distribute them to the policy enforcers.

Policy Enforcers



The policy enforcers in national governments exploit or work with the selected scientific authorities to justify the policies they are required to enforce.

Policy Propagandists



The propagandists and hybrid warfare specialists are tasked with convincing the public to accept and hopefully believe in the policies. They use psychological manipulation, disinformation, misinformation, censorship and propaganda

Policy Subjects



We the people are the subjects of the policies that cascade down through the G3P system. These are funded via taxation and public borrowing, which benefit the BIS and the central banks and their corporate partners. The system is designed to exploit us, but we are an increasingly unnecessary component as the G3P seeks to transform the global economy based upon the financialisation of nature.

What is really happening? Military attack.

- Not a global pandemic of deadly pathogen. Theatrical production
- Not a drug development process. Theatrical production.
- Not drugs or vaccines. mRNA class of biochemical weapons.
- **Covert** globalist overthrow of US Constitutional republic, through **automatic triggers** in US law suspending constitution, criminal code under “**public health emergency**” conditions.

Budget problems: Solutions other than mass murder

Put the question to state residents.

OR

- Shut down SC health care, pension, education, charity programs; break financial link between South Carolina gov't, feds, central banks.
- Expand existing/establish new **private** health care, schools, charities, mutual aid societies.
- Establish state currency and state bullion depository.
